Minutes of Travis County Emergency Services District #3

August 24, 2020

Attached to and incorporated into these minutes is a copy of the official agenda for the August 24, 2020 meeting.

The meeting was held electronically via a ZOOM connection and not in person, due to the COVID pandemic.

<u>Under Agenda Items 1 & 2</u>: Commissioner President Edd New called the Travis County Emergency Services District #3 (TCESD# 3, the District) Board of Commissioners' regular meeting to order at 7:00 p.m. via a ZOOM connection. A quorum was established with Commissioners Carroll Knight, David Detwiler, John Villanacci and Matt Escobedo present.

Fire department personnel present at the meeting included: Chief Wittig, Business Manager Holloway and Battalion Chiefs Patton.

Under Agenda Item 3: There were no Visitors comments.

<u>Under Agenda Item 4</u>: Commissioner Villanacci moved to approve the July 27, 2020 regular meeting minutes. Commissioner Knight seconded the motion, which carried unanimously.

<u>Under Agenda Item 5</u>: The July Treasurers monthly reports were reviewed. Commissioner Knight moved to approve. Commissioner Detwiler seconded the motion, which carried unanimously.

<u>Under Agenda Item 6</u>: Checks and distributions over \$2,000 were reviewed for the period of July 23rd to August 20, 2020. Commissioner Villanacci moved to approve. Commissioner Detwiler seconded the motion, which carried unanimously.

<u>Under Agenda Item 7:</u> Discussion regarding the sale of Quint 302 ensued. Texas Firetrucks would market Quint 302 for sale at a commission rate of 7%, capped at \$12,000 with an asking price of \$340,000. Chief Wittig requested an approval vote to sale Quint 302 on the previous parameters. Commissioner Detwiler moved to approve. Commissioner Villanacci seconded the motion, which carried unanimously.

<u>Under Agenda Item 8:</u> A proposed tax rate was discussed for required publication in the newspaper styled "Notice of Meeting to Vote on a Tax Rate". The formal vote on the proposed rate would be at the next regular meeting held on September 28th. After discussion Commissioner Detwiler proposed at tax rate of .0790 per hundred value. Commissioner Escobedo seconded. Business Manager Holloway ask for a show of hands on approval. All five Commissioner's raised hands on the affirmative to propose a tax rate of .0790 per hundred value which was unanimous.

<u>Under Agenda Item 9:</u> The Commissioners reviewed the Sales Tax Status Report for July.

<u>Under Agenda Item 10</u>: Chief Wittig presented the Monthly Status Report for July.

Under Agenda Item 11: There were no announcements.

September 2020 Sales Tax Summary

Our September sales tax allocation was \$311,596. This was up 6.4% (+\$18,633) compared to September 2019 and up 13.3% (+\$440,736) at the end of our fiscal year and was our highest ever September allocation.

Our top 10 large companies accounted for 48.9% (+\$288,256), our top 30 large companies accounted for 67.4% (+\$364,842), and our top 100 large companies accounted for 86.7% (+\$417,012) of our total fiscal year collections.

The out of state marketplace "Single Local Tax Rate" allocation for September was \$2,302 (+\$18,740* fiscal year to date). *Allocations began in December 2019.

The September allocation reflects sales made during the month of <u>July</u>. The data continues to show strong online retail trade performance and increases continuing from both construction and landscaping vendors compared to last year.

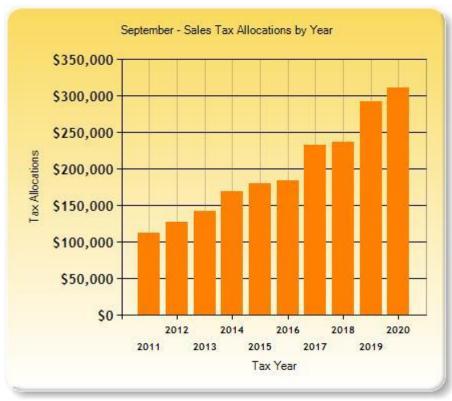

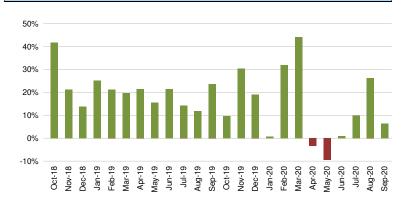

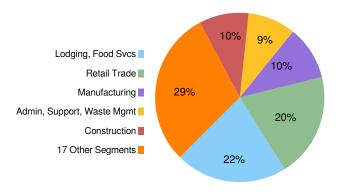

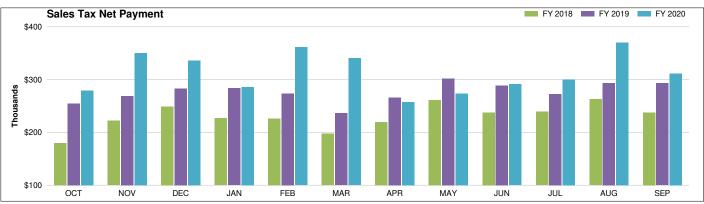

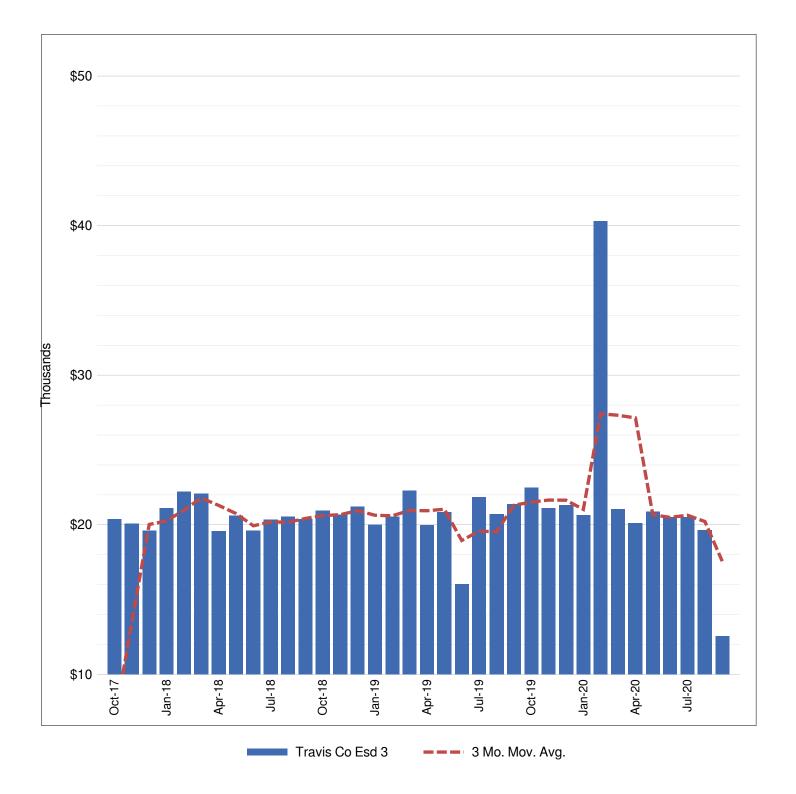

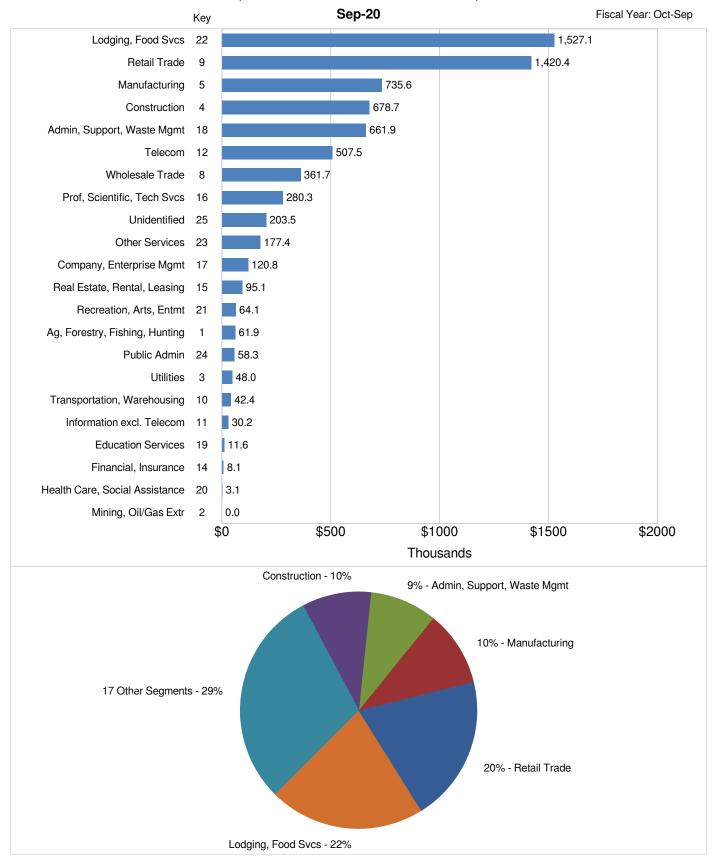

INDUSTRY SEGMENT SALES TAX RANK & DISTRIBUTION

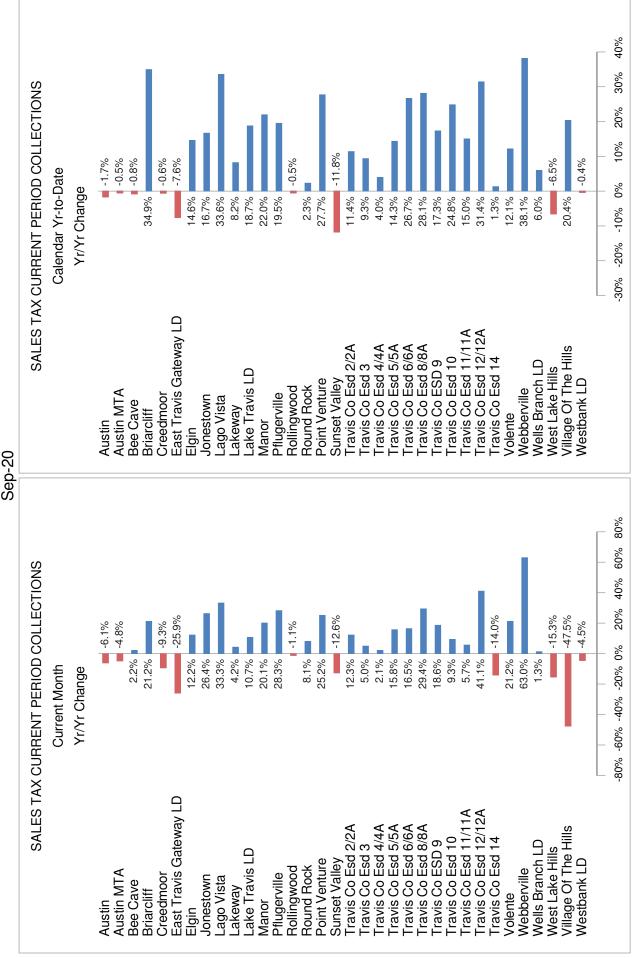

August 2020 Report

Significant Events

<u>August 5 (A) – Brush Fire (AutoAid Received – Austin) – 9301 Sandstone Court</u> [ENG301] E301 was dispatched to a grass fire. BT301 responded with E301. Enroute dispatch upgraded from a grass fire to a brush alarm. BAT301, E37, and BT37 were assigned to the call. E301/BT301 approximately arrived at the same time BAT301 did, BAT301 had command. E301 assigned BT301 to knock down the right flank (closest to a structure) and assigned E301 driver to knock down the left side with the booster line once at the fire. E301 provided a report face-to-face with command. After controlling the fire perimeter, BT37 and BT301 began mopping up.

[BAT301] Battalion 301 arrived on scene and assumed command of the incident. There was approximately 1/2 acre on fire which was about 10 feet from a residence. BT301 went down by the residence and worked on knocking down that portion of the fire. E301 driver and LT pulled the booster line and started to knock down the other end of the fire. E37 and BT37 arrived on scene and I gave them the assignment of working on the north side of the fire. The fire was knocked down in about 15 minutes. We then made the area "Cold Out." I obtained owner information and talked with TCSO and they were going to give them a warning for having a fire in a fire pit during a burn ban. I cleared the scene and went back into service.

<u>August 13 (B) – Brush Fire (AutoAid Given – CE-Bar) – 10203 Spotted Fawn Circle</u> [BT302] BT302 first arrived and made offensive attack on head of the fire. BT302 went around to flank the fire on the right side. Once fire was knocked down, BT302 then did water shuttling to all the other Brush trucks while they were all mopping up the fire.

[BAT302] BAT302 responded to a brush fire. Upon arrival, Command assigned BAT302 to Zulu Division. BAT302 had BT302, BT602, and E32 in Zulu Division. The crews from Zulu Division began extinguishing the fire. We were able to control and contain the fire before it got out of control. The crews used handlines and hand tools to completely extinguish the fire. BAT302 meet with PEC and the Fire Marshal to try to determine the cause of the fire. Command assigned BAT302 to investigate other areas of the neighborhood to make sure there weren't any other spot fires. After completing the task, Command released BAT302. BAT302 cleared the scene and went back in service.

<u>August 19 (B) – Brush Fire (AutoAid Given – Austin) – 7501 US Highway 290 West</u> [ENG301] Engine 301 cleared a call at Seton Southwest Hospital and was then assigned to a brush fire at the Convict Hill / W US HWY 290 area. E301 turned the truck around on HWY 290 and could clearly see a large smoke cloud rising at the 7501 HWY 290 area. E301 did not have BT301 because we were already out on a non-fire call. E301 positioned for best access to the fast-moving brush fire and close hydrant access. A 3" supply line was pulled toward the heel of the fire and the 2" attack bundle was deployed. The other Firefighter carried the wildland pack for a progressive lay. The 3" line was charged, bundle deployed, and an initial knockdown of the north eastern flank was achieved. It was at this time we realized how large the fire was and that it was pushing south and east at a rapid pace. E301

crew extended the wildland pack off of the end of the attack bundle and continued to extinguish the north and eastern parts of the fire. Incoming units were directed by E301 LT until command was taken by the Q27. On the far eastern flank, 2 homes and 2 tool sheds were threatened. E301 crew worked its wildland progressive lay along with BT37 and halted the process of the eastern flank. The rest of our efforts were directed to "mop up" which involved ensuring the fire was totally out. All units cleared, leaving E301 as the last on scene. After a final round of mop up around the fire, E301 collected its hose and tools and cleared the scene.

[QNT302] Q302 responded code 3 to a brush alarm with BT302. Q302 arrived on scene and was directed to report to the church parking lot for Zulu division. Q302 set up in the parking lot and raised the stick for observation if needed. After the fire was extinguished, Q302 was cleared off the call by command and Q302 and BT302 returned to service.

[BT302] BT302 responded code 3 to a brush alarm with Q302. BT302 reported to Zulu division with Q302 and advanced BT302 near the head of the fire that had been knocked down. BT302 assisted crews on scene with hand tools to assist with mop up operations. Command cleared BT302 and Q302 off the call after the fire was considered extinguished. BT302 cleared off the call and returned to service.

[BAT302] BAT302 responded to a brush fire. Upon arrival, E301 was on scene and they had laid out a progressive hose line to begin extinguishing the fire. Q27 arrived on scene and BAT302 assigned then to the Alpha Division. BAT302 assumed Command until BAT08 arrived on scene. BAT302 assumed Zulu Division and moved to another access point to attack the fire. BAT302 had Q302, BT302, and BT902 move to the Zulu Division. The crews were able to make a quick knock down on the fire and then they began to mop up. Command released BAT302, Q302, BT302, and BT902. BAT302 cleared the call and went back in service.

<u>August 20 (C) – Heavy Equipment Fire (AutoAid Received – Austin) – 9200 Flintrock Circle</u> [QNT302] Q302 was called out for a reported brush alarm. After arriving on the scene, the fire was found to be an excavator on fire with access problems. Crew pulled a line off E301 and attacked the fire while Q302 assisted with water supply and man power to assist with fire operations. There was about 100 gallons of diesel fuel spilling onto the ground and burning so we put a tank of foam down to keep the fumes from igniting. A civilian dozer put a perimeter around the fire and cleared a path for access. Once the fire was out, all crews cleaned up and cleared the scene.

[BAT302] Battalion 302 was dispatched to a brush alarm on Derecho Drive with several callers, according to dispatch. E301 was previously dispatched to an auto fire off of Flintrock (a nearby subdivision). BAT302 made it to the crest of Derecho Drive with the only visible smoke East of Derecho Drive. With the previous radio traffic and large black plume of smoke coming from the Flintrock area, BAT302 concluded that these were the same call and advised all units to turn on Ledgestone to access Flintrock. BAT302 asked dispatch to merge the two calls and update the address to the Flintrock address. On arrival, BAT302 made a face to face with E301 and took command. BAT302 assessed the situation to find an excavator that was no longer on fire with a large track of dirt surrounding the unit. There was a bulldozer on site that knocked down all the trees surrounding the excavator and cleared any possible vegetation from the excavator by approximately 50 feet. Beyond the cleared section was a dense fuel load and continuity of mixed fuels (vegetation). E301 knocked down the fire prior to the other units arriving. Q302 was working on setting up a water supply (shuttle operations). BAT302 cleared all other units and remained on scene until several hundred gallons of water and foam brought the excavator to a reasonable temperature.

BAT302 talked with a nearby homeowner about a barbed wire fence and the incident. All units cleared the call and returned to the station.

August 26 (C) – Brush Fire (AutoAid Given – Austin) – 7461 US Highway 290 West [ENG301] Engine 303 and Brush Truck 301 responded to a light brush alarm near the intersection of Highway 290 West and Convict Hill Road. A smoke plume could be seen from the highway as we were approaching Convict Hill and a good access point to the fire was from the parking lot of Legacy Oaks Nursing Home. BT301 was able to easily navigate within 30 feet of the fire. The red line was pulled from the brush truck and the crew assisted with extinguishing the fire with BT37. The size of the fire was approximately 30 x 20 feet and was not moving. This was a homeless camp and several items had burned including appliances, books, furniture, and other household items. Overhanging branches were on fire along with grass and brush. The fire became under control and both crews began mopping up the area. BT301 crew began cutting down smoldering limbs and small trees. Command (Battalion 8) asked if we could empty our tank on the burnt area and we could clear. Both Oak Hill units cleared.

Special Projects Status

- Work on the expansion and remodel at Circle Drive has begun and we are currently
 ahead of schedule. The dorm rooms for both Firefighters and EMS are already framed
 with sheetrock hung on at least one side in all rooms. We encountered some concerns
 with the HVAC system coils as most are 14 years old and showing signs of
 degradation. We are looking into the cost for repair/replacement of some of the most
 concerning units (which is included in part of our normal budget).
- The information for the Insurance Services Office (ISO) re-evaluation is almost complete. We should be ready to submit our last form within a few days with only informational forms outstanding from two of our water suppliers to go.
- We sent one crew of three personnel on the TIFMAS truck to California to assist with wildfire response. They are currently assigned to the "Creek Fire" in the Sierra National Forest (near Fresno) as was 291,426 acres as of September 24.
