NOTES TO THE FINANCIAL STATEMENTS

- 1) Balance Sheet WF Advisors balance is \$339,086. One Certificate of Deposit matured in May in the amount of \$245,000.
- Balance Sheet The net cash balances have increased by \$2,451,549 compared to the same time last year. All other items on the balance sheet are accrual items and do not need to be noted.
- Certificate of Deposit Details There are three other CD's that will mature by July 19, 2022. Once those funds have been deposited into the WF Advisors account, we will purchase four CD's (\$980,000) in early July. Expected rates should be above 1.7%.
- 4) Revenue & Expense May 2022 only. Account 460 Training Fees in the amount of \$13,855 represents billings to Pedernales, Westlake and CE-Bar for their portion of the mobile forcible entry training trailer. Account 493 Reimbursements in the amount of \$148,426 represents TIFMAS payments for the COVID Vaccination Support from May 2021. Account 640 Human Resources was \$97,579 higher last year due to unscheduled overtime related to the TIFMAS deployment.
- Revenue & Expense October 2021 through May 2022. Property Tax collections are \$288,375 lower than last year. That drop is primarily due to the tax decrease from .079% to .065% from 2020 to 2021. Sales Tax collections are \$741,140 greater than last year.
- 6) Revenue and Expense October 2021 through May 2022. Income category 493 Reimbursement of \$358,499 is TIFMAS. Expense accounts #600 and #650 where much higher last year due to the purchase of the new Quint and revamp construction on Station 301.
- Rev-Exp BUDGET for the Year vs. Actual. All account budget variances are within reasonable amounts, except for account 415 Sales Tax Allocation which is \$993,189 greater than budget.
- 8) Net Certified Taxable Property Tax Values have been "conservatively estimated" by the Travis Central Appraisal District at \$4,918,837,404. That value would compute to a NO NEW tax rate of .0530 for 2022-23.
- 9) Checks over \$2,000. Check #17643 in the amount of \$32,917 to J. Reed Constructors for refurbishing the Training Burn Building. That refurbishment contract has a balance of \$21,733 yet to be paid for a total contract of \$54,650. The expense can be seen under account 668 Building Expansion-Improvement in the **detailed** Profit & Loss Statement.

June 2022 Sales Tax Summary

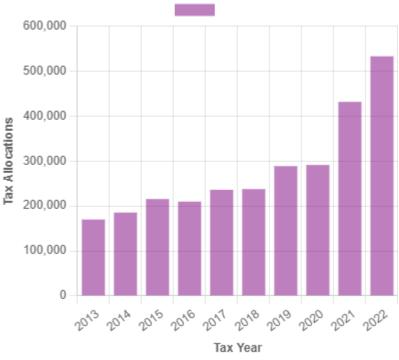
The June allocation reflects sales made during the month of April.

Our June sales tax allocation was \$532,652. This was up 23.5% (+\$101,331) compared to June 2021 and up 25.6% (+\$831,292) for the fiscal year to date. This was our highest June monthly allocation.

The out of state marketplace "Single Local Tax Rate" allocation was \$5,976.

Our top 10 large companies accounted for 55.8% (+\$507,453), our top 30 large companies accounted for 71.0% (+\$610,048), and our top 100 large companies accounted for 86.0% (+\$664,537) of our total fiscal year collections.

We continued to see strong performance in the lodging/food services and retail trade industry segments.

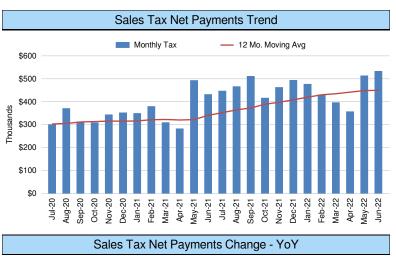

Sales Tax Collections by Industry Segment

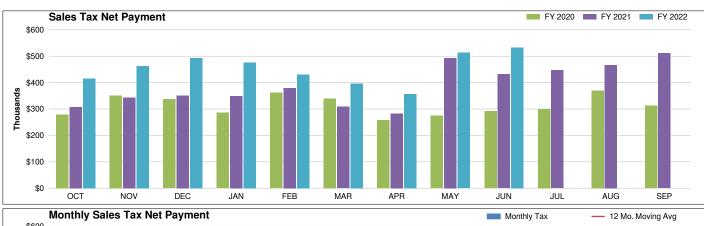


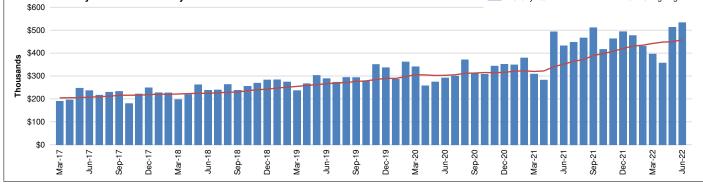

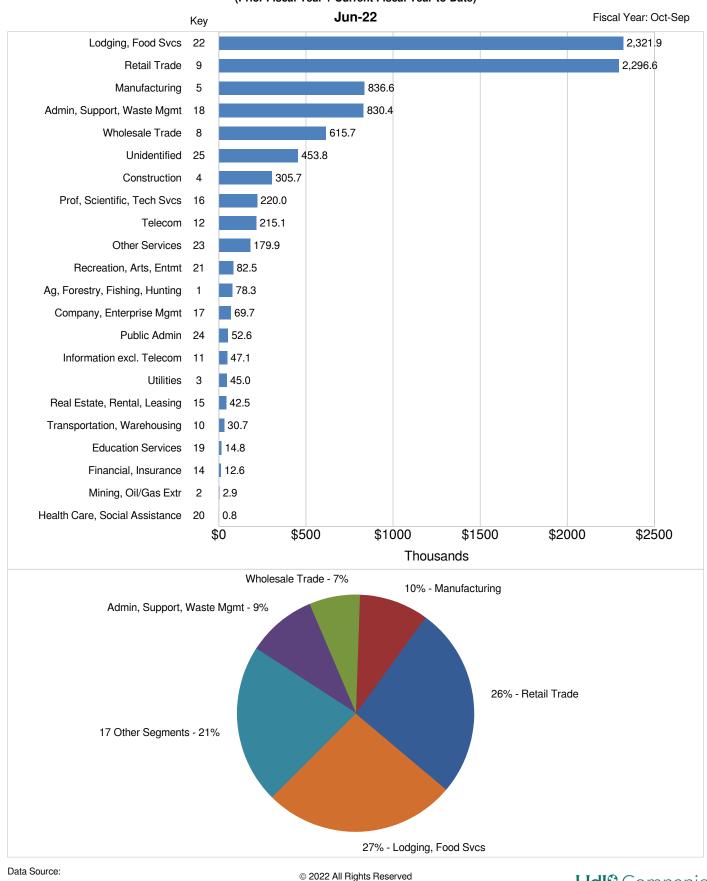

May 2022 Chief's Report

Significant Events

<u>May 3 (A) – Vehicle Rescue – AutoAid Given (Austin) – 7700 West State Highway 71</u> [QNT302] Quint 302 and Engine 37 were called out for a traffic accident. On arrival, E37 was out with two Medic units and upgraded the call to a rescue. There were 2 smaller cars in the middle of the roadway with damage done on both driver's side fronts. E37 and Medic units had patient care and needed Q302 to remove a door on one of the cars to get the driver out. Q302 crew used the spreaders and cutters to remove the door and then helped get the driver out of the car. Once the driver was out, Q302 crew then went over to the other car and assisted the Medics with removing the other driver out of the car. MED32 then asked for 2 riders to ride with them. Q302 then put some absorbent down on the roadway and left the scene of the wreck the way we found it for PD. Q302 was then cleared off the call.

May 3 (A) – Structure Fire – AutoAid Given (Pedernales) – 1612 Poco Bueno Ct

[QNT302] Quint 302 was called out for a second alarm. On arrival, we were told to go to the staging area. Once there, we were told to make our way up to the fire. Q302 was given Inside Division and asked to go in and make sure the fire was out. Q302 checked the second floor and the two attic spaces above the second floor. After some time searching, we could not find any hot spots or smoke production. Q302 then made the call that the fire was out and we left the building. Once outside, Q302 made a face to face with operations and then we were told we could clear the call.

May 5 (B) - Structure Fire - AutoAid Received (Austin) - 8705 High Valley Rd

[ENG301] Engine 301 was dispatched to a reported fully involved two-story structure. As E301 made the scene, visibility diminished on the road the fire was reported on. E301 reported a two-story structure fully involved and E301 would be pulling a rack line and be operating in the defensive mode. The two-story structure was directly behind a residential mobile home. E301 firefighters deployed and stretched the line on the D side of the mobile home. E301 officer was at the D/C corner directing the firefighters to the C side of the mobile home. The fully involved two-story structure had flames impinging on the mobile home. E301 quickly knocked down the mobile home's flames and then directed the stream to the twostory structure. There was a 3-foot walkway separating the fully involved structure and the mobile home. E301 placed the attack line in the walkway with stream directed at the twostory structure and knocking down any flames on the mobile home. E301 driver reported "E301 out of water." E301 shut down the line but remained in position. E301 driver then reported being on hydrant water. E301 began knocking down the fire, trying to protect the mobile home. Command reported water supply issues and E301 running out of water. E301 shut the line down and E301 reported the fire was growing while the lines were down. Command made the decision to pull everyone back. E301 stood by while water supply was established with the priority of getting Q51 aerial operating. After the fire was completely knocked down using Q51, E301 would remain on scene as fire watch being relieved by Q302.

[QNT302] Quint 302 responded code 3 to a structure fire in Station 301's territory. While responding, units on scene had established command with reports of one structure fully involved and starting defensive operations. Q302 was approaching the scene when command was checking on hydrant status in the area. Q302 notified command the closest hydrant would be at the intersection of Summervale and 1826. Command asked Q302 to perform a primary search of the adjoining structure to the one fully involved upon our arrival. Q302 positioned its apparatus along the street to minimize blocking for possible water shuttle operations and reported to the front of the structure. Q302 could see the second structure had fire in the roof and interior of the structure showed to be light to heavy smoke. Q302 crew made entry into the structure to perform a primary search with reports of 2 dogs inside. Q302 crew preformed primary search, found one dog, and was able to get them out and forced entry to one bedroom to complete the primary with only one dog found. Q302 began to help crew inside pull ceiling before conditions worsened and crews backed out. After exiting the structure, Command pulled everyone out due to heavy fire in the ceiling. E301 had run out of water and units were working on water supply while Q302 attempted to shut off power to the structure. Q302 crew pulled out propane cylinders from under the porch and while making access to the power pole to shut off the electric the power pole ignited. Crews pulled back and reported to command post. Q302 roped off the road to limit access under the power lines affected by the burning pole. Q302 notified command that a hydrant was on the street parallel to the incident and maybe a line could be stretched through the yards to avoid having to perform water shuttle operations. Command had Q302 see if it was possible and feasible to access the hydrant on Granada Hills Dr. Q302 made access through one yard to find 4 or more fences to cross and decided the option would not work. After water supply had been established, Q302 was directed to work on the C side of the structure with a hand line. Q302 crew worked on the structure from the exterior and the remains of 2-story structure that had fallen. The decision was made to use Q51 for master stream from the ladder and Q302 crew reported to rehab. After Q51 had knocked down the fire from the aerial, Command began to release units and Q302 took generator to a resident across the street to power their medical device while power was out. Q302 crew helped Q51 load their rack lines up so they could clear. After all AFD units had cleared, Q302 left to go refuel and take a short break and return at sunrise. Q302 arrived back on scene with BT302 and relieved E301. The Travis County Fire Marshal was completing their on scene work and Q302 used BT302 to apply foam to the C side of the structure hitting hot spots. The occupants of the structure were still on scene and Q302 crew assisted them with salvaging any personal items from the structure while putting out hot spots with BT302. While helping with taking out the personal items, it was discovered that there was a pet boa constrictor in an aquarium that was full of water. Q302 crew was able to drain the water out of the aquarium and found the snake was alive. Q302 crew moved the snake and aquarium out to the front yard for the owner. One of the occupants from the residence on scene asked if we carried inhalers that they lost their medications and needed it. Q302 informed them we did not carry inhalers. Q302 called dispatch and had a med call started while taking vitals on the occupant. The occupant refused to be transported and Q302 canceled MED32. Q302 crew obtained a refusal and continued with overhaul operations. TEN301 left to refill and BT302 used one more tank of water on the hot spots. After TEN301 returned, Q302 was able to remove the generator loaned to the neighbor. Q302 left TEN301 on scene and returned to Station 302 for decon and gear swap. After Q302 crew completed decon and gear swap, Q302 cleared off the call and returned to service.

[BAT302] Battalion 302 responded to a structure fire. Upon arrival, there were several units on scene attempting to extinguish the fire. BAT302 met with BAT08 and had a guick face to face. We decided to keep BAT08 as IC and BAT302 would be Operations. BAT302 attempted to do a 360, but conditions wouldn't allow me to complete it. There were various obstacles in the backyard and they were on fire. Furthermore, there was a two-story building behind the main structure that was fully involved. BAT302 made it back to the Command Post and we decided to evacuate everyone in the structure and move to a defensive strategy. Crews began to extinguish the fire from the exterior, but we were not on hydrant water and we had to cease extinguishing the fire. We had other units nursing the attack unit, but water was limited. We toned out 3 more units from AFD and TEN301 to assist us with establishing a water source. Furthermore, we had to focus on an exposure next to the main fire because embers were blowing onto that structure. We notice the fire had spread to the electrical pole and we had to make a Hot Zone were the electrical line was going across the road. The electrical line finally burnt through, but we couldn't have crews go into the Hot Zone because the line was live. This divided the crews and operations until we could get PEC to neutralize the line. We had to use our water sparingly on the main structure until the crews established a hydrant connection on FM 1826. A water supply was established and we used Q51's aerial to knock the fire down. Once the fire was under control, we had AFD's units break down their hoses and clear the scene. We requested the Fire Marshal to help determine the cause of the fire. Q302, E301, and BAT302 remained on scene and waited for the Fire Marshal. We decided to wait until sunrise before we began overhaul due to the hazards in the backyard. BAT302 cleared Q302 for a few hours of rehab to return after the Fire Marshal finished their investigation. E301 stayed on scene and continued putting out Hot Spots. After sunrise, Q302 came back to the scene to relieve E301. We brought TEN301 with Q302 for a water source. The Fire Marshal finished their investigation and BAT302 had Q302 finish overhaul and flowed foam into the structure and the debris in the backyard. BAT302 cleared the scene.

[TEN301] Tender 301 was requested to respond to a structure fire on High Valley Road. Attempts to locate other personnel to respond the apparatus went unanswered, so CM301 called in via radio to dispatch and indicated I would be enroute to Station 301 to respond in TEN301.

I arrived at Station 301, started TEN301, loaded my personal protective equipment into the Tender, and initiated response.

Upon arrival in the area, Firefighters were preparing to close RM 1826 to lay a fire hydrant supply line into the scene. TEN301 was waived past them and proceeded into the neighborhood to the incident scene. Along the route to the scene, an individual wearing a green shirt was standing at the very edge of the pavement, so I requested through my open window that he move back just a bit. He responded with profanity, so I proceeded past him slowly and carefully to minimize any potential risk of injury.

TEN301 was then instructed to pull onto a side street and wait for an engine currently backed in near the rear of E27 to complete pumping their water to them and would then assume that same position in the water shuttle operation. TEN301 then backed up to the rear of E27 and a prompt connection of a 2.5" hose line was made to TEN301's Discharge #2 on the passenger side of the truck. TEN301's pump was engaged and I began pumping water to E27. I reported to E27 and the assigned Water Supply Officer when TEN301'S water tank reached 25% remaining via radio. I indicated an empty tank via the same method shortly thereafter. As TEN301 was running out of water, the fire hydrant supply line connection was made and there was no longer a need for water shuttle operations. TEN301'S pump was disengaged and I proceeded to check in at the Command Post for any other needed assignment. While on scene, it was recommended that the Travis County Fire Marshal's Office be requested, so BAT302 made that request. I also sent a staffing request to off duty firefighters to potentially staff BT301 for a fire standby assignment. I then conducted several media interviews. The fire hydrant supply line was used to refill TEN301'S tank. The supply line was then disconnected, all hose was picked up, reloaded onto the appropriate trucks, and TEN301 cleared the scene to return to service.

May 6 (C) – Structure Fire – AutoAid Given (CE-Bar) – 9102 Atwater Cv

[QNT302] Quint 302 was called out for a reported box alarm in ESD 10. Over the radio, E1001 arrived on the scene and had fire showing from a garage as they pulled a line. Q302 arrived as 4th apparatus, first ladder, and assumed inside truck. After a long walk down the driveway, Q302 Captain did a face to face with the LT on E1001 and then went upstairs to begin a primary search of the apartment above the garage. E1001 had the fire knocked down and was conducting overhaul. Access to the second floor was difficult due to scaffolding blocking the only stairs to the second floor and had a ladder placed to the second floor, but Q302 managed to maneuver our way between the scaffolding and made it upstairs to conduct a search. Search was completed with nothing found but light smoke haze. Q302 then went back down the stairs and began to assist with pulling ceiling with other crews. Q302 officer was now Inside Division. There was still and lot of heat in the ceiling, which was then pulled to gain access to the void space between the floors. The origin of the fire was found to be the Lamborghini in the garage, which was completely burned. After all the levels had gone to zero, crews could work in the environment without air packs. Thermal readings remained low at around 100 and falling. After pulling most of the ceiling, all crew exited the building and conducted a hot wash talk about the fire. After the talk about the fire, Q302 was then cleared the scene by command.

[BAT302] Battalion 302 was dispatched to a structure fire in ESD 10. On arrival, E32, E902, and E1001 were already on scene with BAT901. I joined BAT901 at the Command Post to assist with benchmarks and accountability. I was then asked to do a 360 of the structure. After a thorough 360 of an 11,000 square foot residence, it was obvious that the origin of the fire was a car parked in a three-car garage. During my 360, I met up with several different officers. I obtained and relayed info back to command, including no longer needing to be on air, no longer needing a RIT, and to start demobilizing units with consideration of help needed for the large amount of hose on the ground. I spoke with the homeowner, who said when he was driving his Lamborghini, he heard a pop and figured he would coast back to the garage to let it cool down. He said he came back to check on the car and it was on fire. I asked the homeowners to call for a tow truck and assisted them with turning power back on to the main house. After a debrief, all units were cleared except E1001, who remained on scene until the tow truck removed the burned vehicle.

<u> May 7 (C) – Vehicle Fire – 10711 Indian Scout Trl</u>

[ENG301] Engine 301 responded to a vehicle fire on Indian Scout Trail. A pickup carrying a trailer of equipment was parked on the street in front of the dispatched address and the engine compartment was on fire. The driver and passenger were spraying water on the motor with help from other residents and their garden hoses. Our green bumper line was deployed while the hood was opened. There was visible fire on the sides of the motor. The hottest area was the brake master cylinder and the hood's insulation pad was lying on top of the motor. No fire extended into the driving and seating area. The driver and passenger did not speak English, but a neighbor had a video of what transpired.

The video showed the pickup having trouble driving, possibly due to the heavy load. The driver and passenger immediately exited the pickup to assess the problem and realized the engine compartment was on fire. The radiator fan was on the ground, but it may have been due to the hose stream.

Travis County Sheriff Deputies were on scene and arranging for a tow truck with the owner of the pickup. E301 picked up equipment and cleared.

May 21 (A) - Structure Fire - Mutual Aid Given (North Hays) - 144 Terrace Ct

[ENG301] Engine 301 responded to a structure fire. On arrival, there were multiple units on scene extinguishing the fire. North Hays FD asked us to relieve the fire attack crew to finish extinguishing the fire in the second story attic. E301 made entry, relieving the attack crew. One FF had the nozzle while the other two FFs were pulling ceiling. There was no visible fire, only hot spots through the TIC.

While pulling ceiling, a large piece of sheetrock fell and hit a FF on the head, causing injury. I then helped the FF walk out the front door and asked for one more FF to help us with fire attack. E301 continued pulling ceiling and hitting hot spots. Command then came over the radio and asked us to pull out to re-evaluate. E301 exited the structure and went to rehab. After resting in rehab for a few minutes, we were asked to go back in to help with overhaul. After a few minutes of overhaul, we were cleared from the scene by Command.

[BAT301] Battalion 301 was assigned to the incident for approval of Mutual Aid to Hays County ESD #6 for a structure fire. E301 was assigned to the incident and I went as the command element when our crews go out of county for incidents. I arrived on scene as HCESD #6 was on scene with multiple units. I met up with the Incident Commander and asked him what he needed from my crew. E301 was assigned to assist with extinguishment of the fire in the garage and then went inside to the second floor to work on putting out the fire that was in the attic. E301 crew replaced E62's crew and they started to pull ceiling and extinguish the fire in the attic. E301 LT came across the radio that they had an injured firefighter. The firefighter came out of the structure and I took him over to the EMS/Rehab area for evaluation. He stated that as he was pulling ceiling on the second floor, the ceiling came down on him knocking him to his knees.

E301 then finished out the assignment and came out for air bottle swap and rehab. After rehab, the crew went in and worked on putting out hot spots in the house. After that assignment, we were cleared from the incident and E301 went out of service for decon. Battalion 301 went to South Austin Medical Center to pick up the injured Firefighter.

May 27 (A) – Structure Fire – AutoAid Given (Lake Travis) – 4704 Hudson Bend Rd

[ENG301] Engine 301 was called out for 3rd alarm fire. On arrival, we were told to go to the Charlie side. E301 went around to the C side and we started to do overhaul and pull back and cut on the roof. After some time, we were sent out to rehab. After staying there for a while, we were asked to go back out and pick up hose and clean up what we could. Once the hose was all put back up, E301 cleared the call.

[BAT301] Battalion 301 was assigned to the incident on the second alarm. I arrived on scene and assumed Accountability Officer (this is to manage all crews that are working on the incident). I maintained crews that were working the fire and crews that went to Rehab for fluids and to rest. After the fire was under control, the Incident Command then gathered all crews for a quick talk then started to release some of the AutoAid companies. I met with Command and he then stated that he did not need my service anymore and I then cleared the scene and went back into service. There were no injuries at this 3-alarm fire.

May 29 (B) - Structure Fire - AutoAid Received (Austin) - 8802 Scarlet Cir

[ENG301] Engine 301 arrived on scene. E301 reported a small porch fire and would be operating in the offensive mode due to the long driveway and not yet sure if the fire had extended into the house. E301 firefighters deployed a bundle. After making it up the driveway, E301 officer requested a water can be brought up. Neighbor stated the owners are out of town but there are two dogs inside. Once the water can was brought up, E301 used the water can to knock the fire down and extinguish. E301 reported to Command fire knock down and Command had Q51 and E37 assist with checking for extension. Fire was near a burned outlet with multiple wires running into it with a burned winch underneath the outlet. Once it was determined that the fire did not extend into the house, AFD units cleared first. E301 was the last to clear.

[BAT302] Battalion 302 responded to a structure fire. Upon arrival, there were several units on scene and BAT08 had assumed Command. BAT302 meet with BAT08 at the Command Post. The units on scene said they had knocked the fire down with a water pump can and were looking for extension. Also, the units had cut utilities. BAT302 and BAT08 walked up to the scene to see the extent of the damage. We noticed the origin of the fire was isolated to an exterior outlet on the front porch. The crews pulled some paneling off the front of the house to make sure there wasn't any extension. We determined the outlet was overloaded due to extension cords plugged into that outlet. We looked to see if any breakers were tripped, but didn't find any. Shortly after, all units cleared the scene. We advised the homeowner not to turn on the electricity until an electrician could come out.

Special Projects Status

• Water line work associated with the Oak Hill Parkway highway expansion continued this past month. There were two small-scale single day water outages recently and these should be the last outages planned for the next several months.

The Oak Hill Parkway project also continues moving forward with the long-term temporary relocation of the intersection of Circle Drive and Highway 290 to a location just east of Thunderbird Road in the coming months. New asphalt is in place on the south side of Highway 290 with the north side to be placed very soon. The intersection will still operate with a traffic signal.

Asphalt recycling equipment is being erected between the entrance to the Granada Hills subdivision and the new Highway 290 entrance to Seton Southwest Hospital. It is scheduled to be in service in July. A concrete batch plant is scheduled to be in service by November in the same general area. We don't anticipate any significant risk or issues related to the equipment, but our crews have been provided some basic information about their design and operating concepts to be better prepared in the event of an emergency related to the equipment.

Our average response time this month was 6:03 for all emergency incidents. Our 90th percentile response time this month was 8:29 for all emergency incidents. Our 50th percentile (median) response time this month was 5:45 for all emergency incidents.
