NOTES TO THE FINANCIAL STATEMENTS

- 1) Balance Sheet The net cash balances have increased by \$2,462,774 compared to the same time last year. The 2013 Limited Bond Debt was reduced by \$320,000, leaving a bond debt balance of \$500,000. All other items on the balance sheet are accrual items and do not need to be noted.
- 2) Revenue & Expense September 2022 only. Compares relatively to September 2021 except for Sale Tax collections being \$79,374 less than last year. Account 640 Human Resources is \$171,010 higher than last year and is attributed to an Adjusting Journal Entry of \$276,398 on 9-30-2021 recording prepaid expenses, thus reducing the 2021 number to \$408,079. Account 650 Administration is \$66,861 higher than last year and can be attributed to expenses on the Mackey Field Tower and \$10,000 increase in 2013 Bond Debt service.
- 3) Revenue & Expense October 2021 through September 2022. Property Tax collections are \$290,876 lower than last year. That drop is primarily due to the tax decrease from .079% to .065% from 2020 to 2021. Sales Tax collections are \$925,271 greater than last year. Account 493 Reimbursements is TIFMAS monies in the amount of \$370,835.
- 4) Rev-Exp BUDGET for the Year vs. Actual. All account budget variances are within reasonable amounts, except for account 415 Sales Tax Allocation which is \$1,759,459 greater than budget. The YEAR END budget complies nicely to actual numbers on the expense side.
- 5) Checks over \$2,000 to be noted are as follows:
 - J. Reed Constructors \$26,232 was for repairs and minor improvement to the Training Tower.

Schnurr Paining – \$23,936 was for special steel painting of repairs to the Training Tower.

Austin Fire Dept. - \$18,614 was for six months of dispatch fees ending on 9-30-22 Travis County Emergency Services - \$17,592 was for one year of regional radio fees ending October 31, 2023.

1. INVESTMENT POSITION

The District's Investments continue to be consistent with the Investment Policy of seeking safety of capital, liquidity, and return on investment. Thus, as of September 30, 2022, all funds were invested in either, Wells Fargo Bank's High Yield Money Market, Bond Debt Service Funds (secured by US Government agency obligations), Certificates of Deposit, Advisor Sweep account or Tex-Pool (The Texas Investment Pool service for Public Funds sponsored by the State Comptroller).

2. BOOK AND MARKET VALUES

Because of the nature of the District's Investments, book value and market value are the same for each fund, which had balances as of September 30, 2022 as follows (with the current rate of interest shown in parentheses):

3. MATURITY DATES

All of the District's Investments are available for immediate withdrawal, except for the Bond Debt Service Funds which are set aside for payment on the respective Bonds and cannot be withdrawn by the District.

4. WELLS FARGO INVESTMENT ACCOUNTS

As of September 30, 2022 Wells Fargo held \$7,175,714 of total deposits of which FDIC insurance covered \$500,000 of those deposits. Deposits requiring collateral totaled \$6,675,714. As of September 30, 2022 BNY Mellon Bank held \$7,114,567 in fair market value FNMA and FNMS Notes in the Districts behalf for Wells Fargo Bank. Thus, the District was OVER collateralized in the amount of \$438,853. A UNDER collateralization occurs when Certificates of Deposit mature and are deposited into the Advisor Sweep account, which is considered an "investment" account. This investment account (Sweep) has separate loss protection of \$500,000 via Securities Investor Protection Corporation (SIPC) which is in addition to the FDIC coverage mentioned above. The District is often under collateralized for one to two days after the State of Texas Comptroller deposits the net Sales Tax proceeds which often is over \$450,000. Wells Fargo captures that large deposit on their systems and increases the collateral values

5. POOLED INVESTMENTS (Tex-Pool)

within a two day period.

Tex-Pool is managed by Federated Investors which seeks to maintain a "net asset value" of \$1 per unit. Current balances as of September 30, 2022 in each respective accounts are \$2,934,185 and \$605,595 with an effective interest rate of 2.38%.

October 2022 Sales Tax Summary

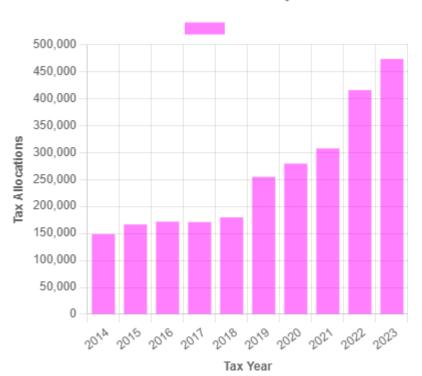
The October allocation reflects sales made during the month of August.

Our October sales tax allocation was \$473,139. This was up 13.9% (\$57,638) compared to October 2021 and up 13.9% (+\$57,638) for the fiscal year to date.

Our top 10 large companies accounted for 58.7% (+\$44,054), our top 30 large companies accounted for 71.2% (+\$33,480), and our top 100 large companies accounted for 85.9% (+\$39,520) of our total fiscal year collections.

We continued to see strong performance in the lodging/food services and retail trade industry segments with each accounting for slightly over ¼ of our monthly distribution.

**The notable decrease we saw from Omni last month appears to have been temporary as they are up almost 18% this month compared to October 2021.

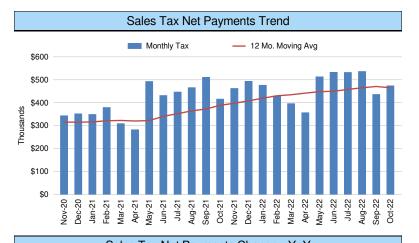

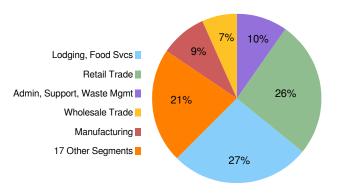

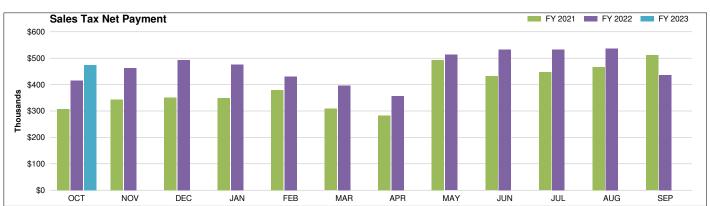

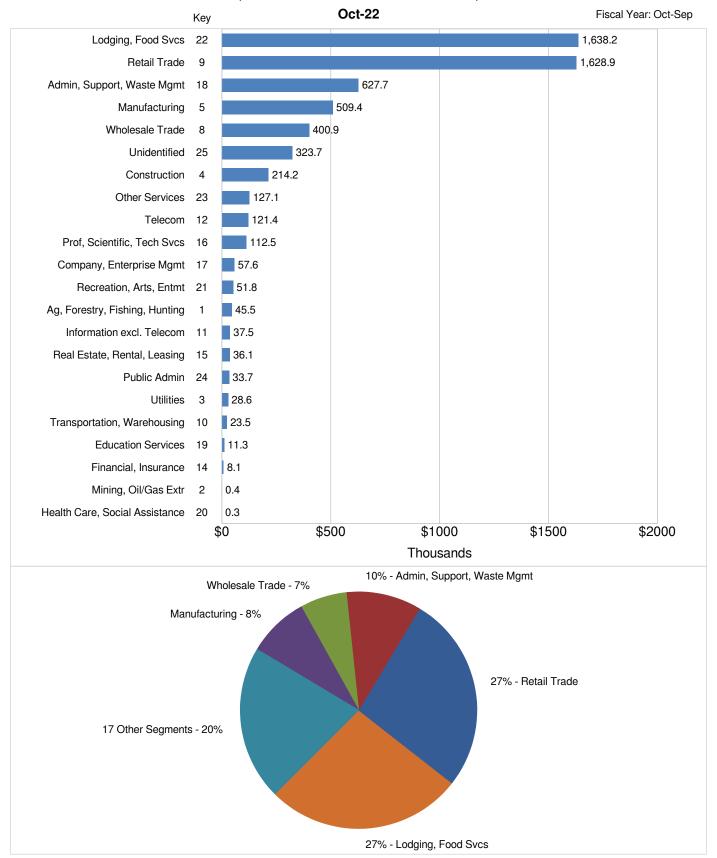

INDUSTRY SEGMENT SALES TAX RANK & DISTRIBUTION

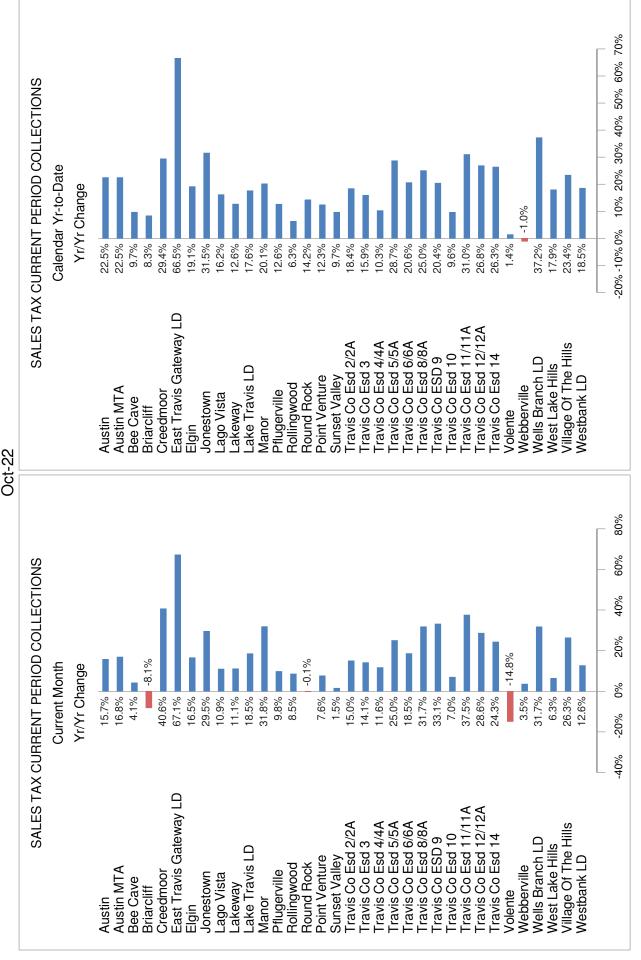

Significant Events

September 14 (B) – Gas Leak – 9204 Eddy Cove

[QNT302] Quint 302 responded code 1 to a hazardous condition. Upon arrival, Q302 met the caller who was reporting a faint smell of gas in their attic. The occupant had just had the house inspected the day before and nothing was found. Q302 crew checked the interior and attics of the structure with the multi gas and sniffer. The first attic area had a faint smell to some members, but nothing found with the monitors. When crew checked the second attic, the multi gas found 1 ppm. Q302 crews sprayed all exposed gas lines in the attic area with soapy water and found a small leak going into the furnace. Crew was able to turn off the valve and stopped the leak. Q302 informed the occupant of what was found and they called a plumber. Q302 cleared off the call and returned to service.

Special Projects Status

- We participated in a joint Public Education project with all of the Travis County ESDs to create a Fire Prevention Week video for distribution. The video and FPW messaging launched the second week of October and was sent out on our Facebook, Twitter, and Nextdoor pages.
- We have contacted several potential firms to ascertain if they can perform the land use and future population research project along the Highway 290 corridor. We will screen their responses and keep you updated on what we are able to find.
- The Open House was held on Thursday, October 6, from 3:30-7:00 PM at Station 301.
 We had a steady stream of community members attend. There were hundreds of attendees and all seemed to have an enjoyable time.
- We have engaged the engineer we utilized for our training field for a review about granting an easement to the West Travis County Public Utility Agency (WTCPUA) for a pump station. We will discuss this further with our attorney once the review is concluded.
- We conducted a hiring process on October 20-22 to be able to set our hiring list for the next year and hire our remaining two authorized positions.

Our average response time this month was 6:52 for all emergency incidents. Our 90th percentile response time this month was 10:26 for all emergency incidents. Our 50th percentile (median) response time this month was 6:00 for all emergency incidents.
