# NOTES TO THE FINANCIAL STATEMENTS

- 1) Balance Sheet Cash and Investments stand at \$18,098,997 as of March 31, 2024.
- 2) Two CD's were acquired on 3/11 and 3/20/24 in the amount of \$245,000 each carrying a 5.00% rate.
- 3) Revenue & Expense March 2024 only. Interest Income is up by \$19k. Property Tax is up by \$9k and Sales Tax down by \$3k. Human Resource costs are up by \$94k and is related to increased payroll numbers due primarily to TIFMAS.
- 4) Year to date compared to same time last year. Revenue items are up by \$297k compared to last year (excluding TIFMAS of \$464K) and expenses are up by \$300k. Net Revenue for the six months ended March 31, 2024 is \$1,719,510.
- 5) Year to date Budget vs. Actual is on track for the last six months with most of the variances being positive or \$743K YTD.
- 6) TCAD has issued an ESTIMATED 2024 Net Taxable value for the District. That number is \$5,824,520,221. A NO NEW tax rate would equate to .0380
- 7) Checks over \$2,000 are detailed in the Memo column with no disclosers needed.


## April 2024 Sales Tax Summary

The April allocation reflects sales made during the month of February.

Our April 2024 sales tax allocation was \$518,471 which was up 27.0% (+\$110,158) compared to April 2023 and up 4.5% (+\$150,107) year to date compared to last year.

Our top 10 large companies accounted for 57.8%, our top 30 large companies accounted for 70.5%, and our top 100 large companies accounted for 85.5% of our total fiscal year collections.

Reductions continued in the construction and lodging industries. In the landscaping area specifically, some businesses were slightly down while others were up more significantly.








Sales Tax Net Payments Change - YoY

# Companies CONSENSUS FORECAST MARCH 2024

## Summary

Positive news is the foundation of this quarter's report, with inflation easing, albeit not at the pace initially projected. This is reflected in the Federal Reserve's recent decision to hold interest rates steady in the near term. Consumer demand, with its outsized impact on the national and state economy, is expected to remain strong, stoked by increases in real wages and elevated household net worth. Lingering concerns over the amount of consumer debt remain a moderating consideration. The U.S. and Texas economies remain solid and moderate expansion is expected through 2025. While projected rates of growth will remain cool in some business categories, HdL's Texas Forecast continues to predict statewide, aggregate YoY local sales and use tax trends will remain positive through 2025.

# **Texas Sales Tax Trends**

HdL's most recent quarterly sales and use tax allocation dataset suggests uneven results, but overall growth. Consumer demand is driving positive trends in the retail sector, with Internet Retail running especially hot as consumers turn to online shopping for convenience and to maximize buying power. However, robust Internet Retail trends come at the expense of brick-and-mortar retail sales, which make up the core of the General Retail category. In response, HdL has strengthened Internet Retail predictions, but projects General Retail results will remain soft through year-end 2024. Slight improvement is expected in the latter half of 2025. HdL expects improved YoY results in the Restaurants & Entertainment category, with restaurants and hotels ranking among the top categories nationally for growth in consumer spending over the past year.

In the Construction & Manufacturing category, high interest rates and borrowing costs have cooled the state's housing market. Consequently, demand and prices for construction materials have leveled. However, Texas remains a popular destination for workers seeking employment, with Texas adding more jobs over the past year than any other state. HdL expects demand for construction services to remain steady in the near term and accelerate in the late stages of 2024 and into 2025 as interest rates ease. HdL has improved its trend outlook in this category beginning in late 2024 accordingly.

HdL's forecast tool, developed to allow clients to adjust HdL's statewide guidance to reflect local realities, has been updated to reflect the most recent year-over-year business category projected trends through December 2025. The March 2024 edition of Beacon Economics' National and Texas Economic Drivers is also included to provide additional insights about key drivers of the national and Texas state economies.

They also told the driver to stay inside the truck until help arrives. E301 called for Austin Energy to help with the issue. In the meantime, E301 made contact with the driver and instructed him to stay where he was. After a while, Austin Energy arrived to cut power and remove the wire from his truck. E301 cleared the scene.

## **Special Projects Status**

- We have completed all but one of our annual wellness physicals. We will schedule the one remaining Firefighter who was unable to complete this once he is able to return to duty.
- We increased staffing on Monday, April 8, for the solar eclipse. We added two
  personnel on overtime to staff a brush truck to be able to respond to smaller incidents
  or to provide better maneuverability if traffic congestion became an issue.
  We encountered five incidents during this time period, two of which were responded to
  by Austin Fire and two were our apparatus responding into Austin through AutoAid. No
  incidents were coded as collisions.
- We have continued meeting with the Travis County Fire Chiefs and with Austin/Travis County EMS regarding call processing time for medical incidents. A workgroup has been established to work toward solutions for reducing the amount of time from processing a 9-1-1 call for medical services to dispatch of appropriate fire department resources. A potential solution has been identified and work is commencing to identify the exact procedure and changes needed to implement it. It is believed this will return EMS call processing times to pre-May 2022 status. The chart below recently made available to us shows the EMS Response Time
