Minutes of Travis County Emergency Services District #3

August 26, 2024

Attached to and incorporated into these minutes is a copy of the official agenda for the August 26, 2024 meeting.

<u>Under Agenda Item 1 & 2</u>: Commissioner President Edd New called the Travis County Emergency Services District #3 (TCESD# 3, the District) Board of Commissioners' regular meeting to order at 7:00 p.m. A quorum was established with Commissioners Carroll Knight, David Detwiler, and Matt Escobedo in attendance. Fire department personnel present at the meeting included: Chief Wittig, Business Manager Herb Holloway, and Firefighters Hartigan and Lyngaas.

<u>Under Agenda Item 3</u>: There were no comments.

<u>Under Agenda Item 4</u>: The minutes of the July 22, 2024 Regular meeting were reviewed. Commissioner Escobedo moved to approve. Commissioner Detwiler seconded the motion, which was carried unanimously.

<u>Under Agenda Item 5</u>: The Treasurers Report ending July 2024 was reviewed. Commissioner Knight moved to approve. Commissioner Escobedo seconded the motion, which was carried unanimously.

Commissioner Escobedo seconded the motion, which was carried by a majority vote of three to one.

<u>Under Agenda Item 8</u>: The Proposed Property Tax Rate of for 2024-2025 and Public Notice was reviewed and discussed. Mr. New proposed a property tax rate of .0530 which is below the Voter Approval Rate, but above the No New Revenue Rate. A notice of Meeting to Vote on the proposed tax rate of .0530 will be published in the Austin Chronicle on September 6, 2024. Commissioner New moved to approve. Commissioner Detwiler seconded the motion, a show of hands determined ALL were in favor of the proposal.

<u>Under Agenda Item 9</u>: The Dispatch Interlocal Agreement with Austin Fire was not ready for review. No action was taken.

<u>Under Agenda Item 10</u>: President New called a closed meeting under Texas Government Code 55.074 at 8:18 p.m. relating to Personnel Matters. The Closed meeting was reopened into the Regular Meeting at 8:35 p.m. Commissioner Escobedo made a motion to authorize President New to proceed as discussed, which was carried unanimously.

NOTES TO THE FINANCIAL STATEMENTS

- 1) Balance Sheet Cash and Investments stand at \$18,239,500 as of August 31, 2024, which is an increase of \$117,913 from the prior month.
- 2) Treasury Notes The investment strategy is yielding an average rate of return of 4.87% or \$292,200 per year. Change in ending values from the prior month has increased by \$28,423 to a total value of \$6,015,862.
- 3) Four CD's matured in August. The maturing CDs are being deposited into the Wells Fargo Cash Sweep account and the funds will be reinvested into five new CD's in September.
- 4) Revenue & Expense August 2024 only. Interest Income is up by \$43k. Sales Tax is down by \$98k. Account #493 is reimbursements from TIFMAS.
- 5) Year to date net revenue is \$1.8 million.
- 6) Year to date Budget vs. Actual is on track for the last eleven months regarding expenses. Net Revenue is \$1.6 million over budget.
- 7) Checks over \$2,000 to be explained are as follows: Texas Mutual Insurance Workers Compensation of \$244k is for the year 2024-2025 and is up by \$22k from last year.

September 2024 Sales Tax Summary

The September allocation reflects sales made during the month of July.

Our September 2024 sales tax allocation was \$510,495 which was up 10.1% (\$46,645) compared to September 2023 but down 20.9% (\$1,630,120) year to date compared to last year (still impacted by the large audit collection in July 2023).

Our top 10 large companies accounted for 57.9%, our top 30 large companies accounted for 71.7%, and our top 100 large companies accounted for 85.7% of our total fiscal year to date collections.

Increases for this month compared to last year came from both of our main construction industry businesses, some of our landscaping contractors, and the new Discount Tire location we expected to see after their first full month of activity.

September - Sales Tax Allocations by Year



Sales Tax Collections by Industry Segment







INDUSTRY SEGMENT SALES TAX RANK & DISTRIBUTION



September 2024 Operations Report

Significant Events

August 17 (C) - Grass Fire - 1920 Barton Creek Blvd

[Truck 302] Truck 302 and Brush Truck 302 responded to a grass fire on Barton Creek Blvd. On arrival, bystanders had pulled their vehicles onto the shoulder of the North side of Barton Creek Blvd. There were 3 – 4 black sections on the North side of the road with a nearby worker spraying water on the spots with a garden hose. BT302 pulled the red booster line to mop up the area. There were no flames and the area was contained to short grass just off the road.

A bystander witnessed a larger truck stopping in this area with sparks coming off their vehicle. There were remnants of hot brake and/or wheel parts on the road close to these burned sections. The vehicle was seen leaving the area by witnesses and we did not see any vehicles pulled off Barton Creek Blvd when returning to the station.

The burned areas were watered down with emphasis on the edges. Both units soon cleared.

<u>August 25 (A) – Extrication of Victim from Vehicle (AutoAid Given – Austin) – 6400 William Cannon Dr</u>

[Engine 301] E301 responded to a traffic accident. As E301 was responding it up graded to an entrapment. On arrival, there appeared to be 2 vehicles involved, a truck and an SUV. There was little damage to the truck, the SUV was on its passenger side with its roof against a yellow barrier. Q51, E27 and Rescue 20 were on scene working with the two entrapped patients. E301 was instructed to bring our hydraulic tools to help with cutting the SUV open for extrication. Q51 instructed E301 to cut part of the sunroof and front windshield off the vehicle. E301 used a reciprocating saw to accomplish the job. E27 then cut more of the roof for better access to the patient. Q51 and E27 were then able to extract the patients out the sunroof, onto backboards, and then onto stretchers. E301 then cleared the scene. [Battalion 301] BAT301 arrived on scene to a two vehicle accident with one vehicle with moderate damage and the other on its side up against a jersey barrier. BAT04 was on scene prior to BAT301'S arrival and had command. BAT301 took over operations with Q51, E27, E301, and RES20 working on extrication. The vehicle was stabilized with 2 struts and units were able to flap the roof open with reciprocating saws. Shortly after, 2 adult female occupants were removed and delivered to ATCEMS' medics for medical treatment and evaluation. BAT301 was cleared shortly after by command. BAT301 cleared and returned into service.

Special Projects Status

- I attended the Travis Coujnty Fire Chiefs' Planning Meeting in Bastrop on September 5 & 6. We coordinated a collective approach to several significant issues facing our Departments. We will continue working together to present more of a single voice for the Travis County Fire Agencies and plan to present information on a more regular basis to the Travis County Emergency Services subcommittee of the Commissioners' Court.
- The TIFMAS Symposium is currently underway, running September 17 through 21 in Waco. Over 225 attendees are registered for the main Symposium and quite a few attendees registered for specialized training classes later in the week.
- We received an email from the Travis County Department of Clinical Performance and Education (DCPE), through which our medical direction is provided. Dr. Kempema has accepted a position in Colorado and will begin work there in January 2025. He intends to continue providing Medical Direction for Travis County, but we will be working with DCPE to ensure our needs are being met and to make sure the schedule and availability being provided are appropriate for both Dr. Kempema and Travis County.
