### **NOTES TO THE FINANCIAL STATEMENTS**

- 1) Balance Sheet The District closed its year end with \$1,646,202 more in cash compared to last year.
- 2) Treasury Bills Change in ending values from the prior month increased by \$19,262 which relates to a average rate of return of 4.0%
- 3) Wells Fargo Advisors balance of \$941,208 will be transferred into four (4) \$235,000 CDs before the end of October.
- 4) Revenue & Expense September 2024 only. Interest Income is up by \$36k. Sales Tax is up by \$50k. Comparing the expenses to prior year are skewed due to the accrual items such and prepaid expense and accounts payable booked in September 2023.
- 5) Year to date net revenue is \$1.6 million.
- 6) Year to date Budget vs. Actual came very close to predications at year end. Net Revenue is \$1.6 million over budget which accounts for the \$1.6 million that is in cash assets. Interest of \$438,902 and Sales Tax of \$1,258,572 over budget accounted for the increase in Net Revenue over Budget.
- 7) Checks over \$2,000 are all self-explanatory.

### **October 2024 Sales Tax Summary**

The October allocation reflects sales made during the month of <u>August</u>.

Our October 2024 sales tax allocation was \$451,558 which was down 17.9% (-\$98,473) compared to September 2023 and down 17.9% (-\$98,473) year to date compared to last fiscal year.

Our top 10 large companies accounted for 51.3%, our top 30 large companies accounted for 67.3%, and our top 100 large companies accounted for 83.4% of our total fiscal year to date collections.

Decreases this month compared to last year came from some of our landscaping and construction companies, including one that reported a negative number. We have requested that our consultant perform some research into that anomaly. The new Discount Tire location continues to show strong performance.

October - Sales Tax Allocations by Year

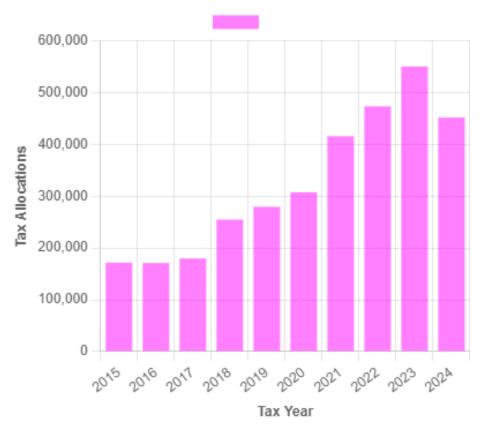

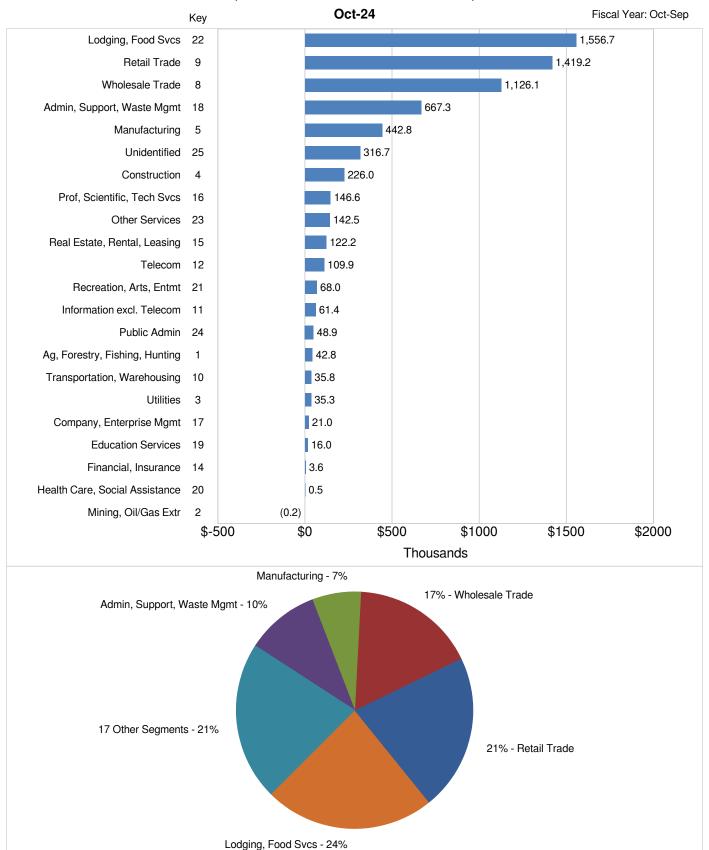

### **INDUSTRY SEGMENT SALES TAX RANK & DISTRIBUTION**

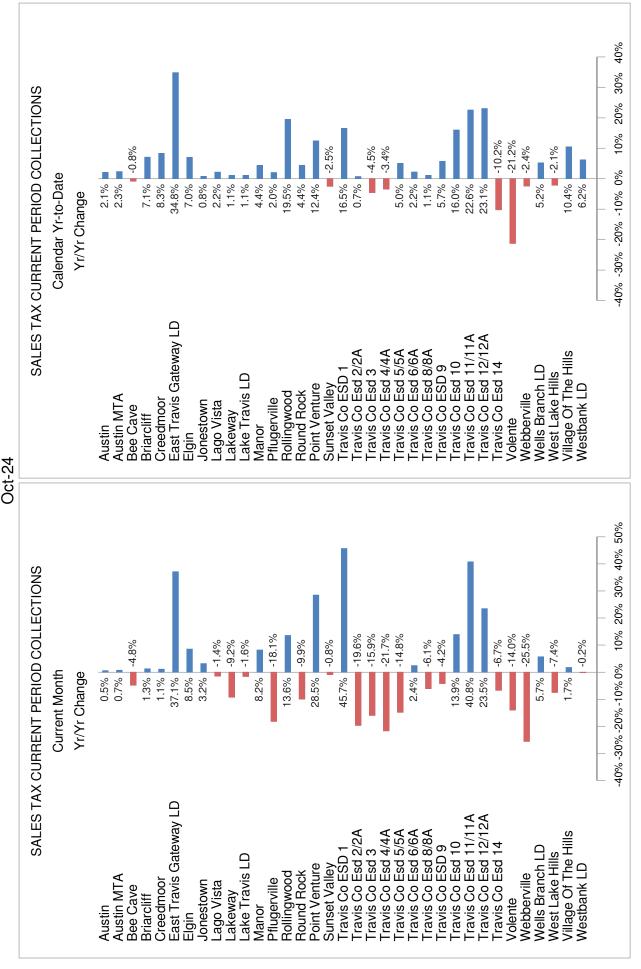

### **October 2024 Operations Report**

### Significant Events

September 12 (C& A) – Structure Fire – AutoAid Given (Westlake) – 6 Sundown Parkway [Truck 302] C Shift: Truck 302 responded to a structure fire on Sundown Parkway in Westlake. This was initially dispatched as a grass fire. E902 arrived first with a brush truck and upgraded the incident to a structure fire. E902 gave a size up that included fire through the roof of a home under construction and declared defensive mode. E902 deployed bundles and began extinguishing fire from the exterior. Command (BAT901) arrived and confirmed a defensive fire and to use an elevated master stream from TK302. On arrival, TK302 deployed the bucket and gained a water supply. It was determined that the elevated stream would not be effective due to distance and the location of the fire. By this time, a good amount of fire had been knocked down and the mode of operation was changed to offensive. TK302 was on deck on the Alpha side. Interior crews were attempting to confine the fire as it was already in the attic space. TK302 was assigned outside division and a 360 was done. Fire and high heat (300 - 500 degrees F) was mostly confined to the Alpha/Delta corner where crews were working. Smoke was also coming out of the eaves all along the Delta side. Inside Division had forced entry near the middle/front of the home to work toward the seat of the fire. Smoke was beginning to come out of the eaves near the middle section of the home and TK302 was re-tasked to go interior to open up ceiling with a hose crew to cut off any fire spread. By this point, 2 hose lines had burst and had been replaced, causing some delay getting water onto the fire. Interior crews also had to withdraw twice due to structural integrity concerns of a second-floor portion (A/D corner), replacing hose, and to regroup. BAT301 had also been assigned Operations and a second alarm was dispatched.

TK302 crew assisted with opening ceiling with a hose team. Temperatures were no more than 150 degrees F. TK302 began moving room by room closer to the Alpha/Delta corner extinguishing any fire in the attic and pulling ceiling where needed. TK302 needed a bottle change and went to recycle and ultimately to rehab.

After rehab, TK302 was assigned to Inside Division to again focus on opening the attic and extinguishing fire and hot spots. RES31 and E31 were on the exterior directing water between the roofing material and decking while TK302 was inside opening ceiling where needed to ensure effectiveness. Other crews were doing the same closer to the Alpha/Delta corner. This continued until we needed another bottle change. TK302 changed bottles and then went to rehab.

Travis County Fire Marshals were on scene to investigate the cause of the fire. An after-action review was done with the Officers.

A shift relieved C shift on scene and C shift deconned at Station 302.

A Shift: A Shift relieved C Shift from the scene and took over the truck. TK302's first assignment was to reposition the truck to better utilize the aerial to put out troublesome hot spots. TK302 repositioned in the driveway and secured a water source. TK302 had two personnel in the bucket working both master streams and began working on hot spots and void spaces. All hot spots were extinguished and checked with a TIC with nothing found. Command cleared TK302 from the scene. TK302 gathered equipment and returned to service.

[BAT301] Battalion 301 was assigned to the incident as the second Battalion Chief. We arrived on scene and met up with the Incident Commander. I was initially given the job of Safety Officer. After Safety 1 (from AFD) arrived on scene, I was then assigned Operations. The initial crews were making a push to knock the fire down when both of their attack hoses developed holes in them, they had to back out. We got additional hose lines in service and the other two were replaced.

I assigned RES31 Officer as my Inside Division Officer. I had a crew going up to the second floor (this was like a bell tower, a 15x15 room) to knock the fire down up there. We then saw that there was significant wall cracking and they had started to bow out. We then pulled the crew off the second floor for safety. Inside Division (ID) was evaluating the Delta side of the building (where the majority of the fire was) and were pulling ceiling to see where the fire had progressed to. After pulling ceiling, the crews could only find heavy smoke until they found a scuttle hole and made entry in there to find out that the entire attic was fully involved with fire. ID communicated to me that fire was running along the entire side of the building. I made the decision to do a tactical withdrawal.

I met with ID and Safety 1 and we created a plan to try to cut off the fire at the Charlie/Delta corner, I then notified Command of our plan. Interior crews went in the Alpha/Charlie part of the building to locate where the fire had progressed. They made 8-10 inspection holes in the ceiling to only find heavy smoke, no fire. The roof on the Delta side had vented itself and pulled a lot of the smoke out of the Charlie section of the attic. I also had a Charlie Division for the exterior as they were working on the Charlie/Delta corner to knock that fire down that was in the attic. Once we identified where the fire was up in the attic, the crews inside made good progress on knocking down the fire.

Once the crews had the majority of the fire knocked down, I met with the Command team and had a quick hot wash with the initial Officers from the first alarm assignment. We then made the decision to have TK302 use their master stream to access places that were unstable (mainly the bell tower). We sent all crews on the fire ground to rehab as TK302 was going to use their elevated master stream to extinguish the majority of the remaining fire. While TK302 was still hitting hot spots on the unstable areas of the fire, I met with Command and we discussed what still needed to be completed and he was releasing some of the AFD units from the scene. I was then released from the scene by Command. I cleared the scene and went back into service.

# <u>September 16 (C) – Structure Fire (AutoAid Received – Austin & North Hays County) –</u> 11100 S West Oaks

[Engine 301] E301 was dispatched to 11100 South West Oaks for a reported structure fire. Upon arrival, E301 assumed command on FTAC203 and reported a vehicle fire inside a detached garage. E301 pulled a bundle for fire attack in the offensive mode. A 360 was performed and the fire was found to be confined to the detached garage. E301 began fire attack on the Alpha side door near the primary residence to protect the residence from fire impingement. After the main fire was knocked down from the Alpha side, E301 repositioned the hoseline to the garage door on the Bravo side. Entry into the garage was limited due to the garage door failing and entangling itself on the vehicle inside. E301 was able to direct water flow around obstacles to extinguish the vehicle fire with limited entry. E37 arrived on scene and assumed backup. E37 then relieved E301 to change air bottles. E37 began work on removing the garage door to facilitate overhaul. The garage was continuously monitored for hot spots using thermal imaging cameras. All hot spots were cooled and large items inside the garage were moved outside onto the driveway where they were further cooled. After the garage was checked for heat multiple times, it was determined that overhaul was complete. TK302 rechecked the attic of the residence for smoke and E301 performed a final 360 of the garage and residence with a thermal camera. E301 put all tools and equipment back on the unit and began the decontamination process.

[TK302] TK302 responded to a structure fire on Southwest Oaks. E301 arrived first and reported a vehicle on fire inside a detached garage, was pulling a bundle, and was in offensive mode. E37 was back up and nursed to E301 and Q51 was Inside Truck. TK302 arrived and was assigned Outside Division by Command with Q51 being assigned Inside Division. The fire had been extinguished and was confined to the detached garage. TK302 did a 360 to check for areas of concern. Temperatures were no more than 150 degrees on the exterior with the higher temperatures in the peak of the garage. E37 was already beginning to overhaul the front of the garage. The electricity was confirmed to be disconnected to the garage. The homeowner later confirmed that the breaker to the garage was tripped. Outside Division crew begin peeling siding on both sides of the garage to ensure all burning had stopped.

The homeowner described fuel leaking after starting the vehicle and a fire starting underneath the motor.

Large items were removed from around the vehicle for a possible investigation by the Fire Investigator. The hood of the vehicle was opened and the motor was cooled down. Crews also pulled all the ceiling to ensure there were no more flames and hot spots. Crews rotated in and out of the garage with TICs and a hose line to continue ensuring all flames and hot spots were extinguished. Overhaul was deemed complete and all crews gathered equipment and cleared. TK302 began the decontamination process.

[BAT302] BAT302 was dispatched to a reported structure fire with AFD. While responding to the fire, we noticed that there was a large black column of smoke in the distance. E301 arrived on the scene and reported heavy smoke and fire showing from a single story detached garage with a vehicle inside on fire and was pulling a bundle down the driveway. E301 used the bundle and attacked the fire from the Alpha side and attempted to cut the fire off from extending to the exposure structure less than 10 feet away. E301 then directed the fire out the garage and away from the main structure. E37 arrived and assumed back up and began to nurse water to E301. BAT302 arrived on the scene and assumed command on Fire TAC203. Command reported E301 was attack with and bundle on the ground, E37 back up with a second line on the ground. AFD Safety 1 on scene and assumed safety. E27 arrived and was asked to spot a hydrant. E43 arrived and staged level 1. Command asked for E43 to assist with spotting a hydrant and then assigned to RIC. Q51 arrived and assumed Inside Truck and TK302 arrived and assumed outside truck. Command called Q51 and assigned them Inside Division and assigned TK302 Outside Division. Q51 then reported that primary search was complete. TK302 reported that utilities had been cut. E27 reported that the closest hydrant was outside the area and across Hwy 290. Command called dispatch to request a tender from Hays County. BAT08 arrived and Command assigned him to get eyes on the fire. Safety reported back to the Command Post with an update on the fire and reported the fire was knocked down and units were in overhaul. Safety also found the homeowner and brought him to the Command Post. The owner stated he was working on his truck and gas spilled out the bottom on the floor finding a heat source and igniting a fire. He stated that he tried to put the fire out and reach for a fire extinguisher, but it was too hot, and he got out of the area. The civilian had breathed in a little smoke and had a minor injury on his arm. The owner was sent to EMS for further evaluation. EMS then later obtained a refusal and cleared the civilian. After the fire was knocked down, all units continued to overhaul the fire and pull stuff out of the garage. Command called for the on-duty Travis County Fire Marshal to contact Command via cell. After the Fire Marshal called, Command updated him with the status of the fire and stated there would be no need for him to come out and felt that the statement the homeowner gave was accurate. The Travis County Fire Marshal was sent the information on the owner and indicated he would do a follow up with him. Command then began to release units from the fire starting with R31 and E43. Then released E27 and held E37, Q51, E301, and TK302 to finish up overhaul. Command spoke with the owners of the

building and gave them info about 1-800-BoardUp. Crews continued to pull things out of the garage and work hot spots. Once the garage was cooled, Command began to clear E37 and Q51, Safety then cleared with BAT08. I had TK302 use a thermal camera and search the attic again to make sure there was no smoke in it. E301 took another TIC and checked the garage for more hot spots. I had E301 use a 5-gas monitor and check levels in the garage which was all zeroed out. Command then had all crews begin to clean up the equipment and release the units from the scene. The owners had been advised that all crew would be released and that they had a representee from Board Up there. All units cleared and FTAC203 was returned to dispatch.

Both E301 and TK302 went back to the stations for decon and clean up. Both crews were given their second sets of gear and then went back in service.

<u>September 28 (C) – Structure Fire (AutoAid Given – Austin) – 9301 Old Bee Caves Rd</u> [Engine 301] E301 was dispatched to a reported structure fire at 9301 Old Bee Caves Rd. Upon arrival, E37 was pulling a bundle to the second floor of a four-story apartment building with white smoke showing. E301 assumed Fire Attack 2 and pulled a second bundle to the second floor. Prior to extending the line, E37 reported the source of smoke was coming from apartment 623 as a result of melted baby bottles on a stovetop. E37 began ventilation of the apartment and E301 was requested by Command to assist a patient with smoke inhalation near the Command Post. E301 proceeded down to the Command Post and assisted ATCEMS who had already established patient care. E301 gathered equipment pulled off the unit and was cleared from the scene by Command. E301 returned to service.

  A list will be circulated after the SAFE-D Board approves the legislative platform.
